Rural Enterprises and Remittances Project (RERP)-SAMRIDDHI is a joint initiative of the Government of Nepal (GoN) and International Fund for Agriculture Development (IFAD). Its strategic goal is "Reducing poverty and achieving sustainable development through employment-focused equitable and inclusive economic development." SAMRIDDHI project is implemented by Ministry of Industry, Commerce and Supplies and funded by International Fund for Agriculture Development (IFAD). The Project's Development Objective is viable rural micro/cottage and small enterprises (RMSEs), both on-farming (supply chain) and off-farming sectors, provide sustainable source of income to rural poor households, migrants, returnees and or their families.

The project is being operated in 16 districts namely: Bhojpur, Terhathum, Dhankuta, Okhaldhunga, Khotang, Sunsari, Morang, Udayapur, Saptari, Siraha, Dhanusha, Mahottari, Sarlahi, Rautahat, Bara and Sindhuli of Province 1, Province 2 and Bagmati Province.
